Update your details in the register's database not only involves recording names, births, wedding dates and dates on which persons have died, but also involves the provision and recording of personal information about an interesting event or anecdote or personal achievements of a Vermeulen that occurs to him or her.

It must be emphasised that the Genealogies and the database are the property of the Bond and that no part thereof may be reproduced in any form or by means of electronic or mechanical manufacturing without written approval from the Bond except when it is used for your own purposes.

Please note that if a Vermeulen marries and he/she adopts his/her partner's surname, the partner's details are indicated in the genealogy, but not the details of their children or descendants. The child is no longer a Vermeulen for the purposes of our genealogy. In the past, however, some of these children's names have been mentioned in our register. Unfortunately, their details cannot be removed now.

The responsibility of collecting genealogy information is not only based on the Bond Management and if every Bond member and Vermeulen descendant helps us by checking his or her information in the genealogy and let us know about the changes, it will make our task that much easier. It is in the interest of yourself to make sure that your information is up to date. Data for the last 20 years is no longer readily available and is no longer provided by institutions. If we want to establish an updated with correct information genealogy for our offspring which they will be proud of, it will be the responsibility of each of us.

The Management of the Bond is willing to upload the information to the database. We just need to get the correct information. Make sure the information you supplied, is correct. The source from which we obtain the information is also specified and if you supply the info your name will be indicated as the source in our database.
